## ENTRY RULES

.....

1. The competition is open to violinists, violists, cellists and double bassists of any nationality.
2. The Competition is open to contestants born after **December 31, 1999**.
3. Candidates who have already won previous editions of the Claudio Scimone International Prize cannot enter.
4. The application to enter the competition, with all the components listed below, on paper without duty stamp and signed, must be received not later than **Saturday 19 October**, by email to [segreteria@concorsoscimone.it](mailto:segreteria@concorsoscimone.it) with subject line: **“Entry Application New Edition of the Claudio Scimone International Competition 2024”**.
5. The entry application with all its components must be signed or countersigned by a parent or guardian of Candidates who are minors.
6. Entry applications received after the indicated deadline will not be considered valid.
7. The entry application will be considered complete with the submission of all the following forms fully completed and/or signed):
  - a. Forms A, B, C, D, E, in PDF **fillable digitally format**;
  - b. Valid identity document, in PDF format and tax code (if residing in Italy);
  - c. Color artistic photograph of the Candidate, in JPEG or PDF format;
  - d. Receipt of payment of the entry fee, in PDF format.

- It is forbidden for Candidates to contact members of the Jury.
- The Scimone-Pancolini Prize is indivisible.

## COMPETITION STRUCTURE

### FIRST PHASE

The FIRST PHASE involves the evaluation of the titles and audio-video material submitted by Candidates with one or more links posted on YouTube: audio-video files must be recorded without editing and/or post-production and must have a maximum total duration of 15 minutes.

2. Each piece must be recorded specifically for this evaluation and uploaded to YouTube no earlier than the date of the call. Candidates must certify the authorship of the recording, guaranteeing its authenticity in every part. In order to avoid cases of self-plagiarism, any file submitted that does not comply with these rules will not be admitted.
3. No liability may be attributed to the organisers of the Competition in the event of undetected fraud or content that may violate current laws and regulations. Any infringement found will be reported to the appropriate authorities.
4. After evaluation of the audio-video material, the Jury will select the eligible Candidates for the SECOND PHASE by 23.59 CEST on **Monday 28 October 2024**.

## SECOND PHASE AND ANNOUNCEMENT OF THE WINNERS

1. Candidates selected for the Second Phase will be called for an audition on **Thursday 14 November 2024** at the "Cesare Pollini" Auditorium in Padua.
2. Each Candidate will be invited to play in alphabetical order, starting with the letter drawn by the Jury on the previous day and published on the official Website of the Claudio Scimone International Competition: [www.concorsoscimone.it](http://www.concorsoscimone.it)
3. Candidates must perform two pieces of different style and character, with a maximum total duration of 15 minutes.
4. Prior to the performance, Candidates must provide the Jury with copies of the chosen pieces.
5. The Competition organisers will provide an accompanist, if so requested by Candidates (Form C).
6. At its sole discretion, the Jury may decide to have Candidates perform only a part of the programme they have submitted, which must in any case not exceed 15 minutes.
7. The session will be open to the public in compliance with current legislation.
8. At the end of the Second Phase, the Jury will decide the winners of the Prizes and Scholarships of the New Edition of the Claudio Scimone International Competition 2024. The Prize winners will agree with the Jury the programme to be performed in the final concert which will take place on **Sunday 17 November 2024 at 11 am**.

## FINAL CONCERT

The Prize winners of the New Edition of the Claudio Scimone International Competition will play in the *I Solisti Veneti* Concert on **Sunday 17 November 2024 at 11 am**, dedicated to Claudio Scimone and directed by M° Giuliano Carella, at the "Cesare Pollini" Auditorium in Padua. At the end of the concert, the Prizes and Scholarships will be presented to the winners of the *New Edition of the Claudio Scimone International Competition 2024*.

Dear Sir/Madam, In accordance with the provisions of EU Regulation 2016/679 on the protection of natural person with regard to the processing of personal data, the **Claudio Scimone International Competition Committee** hereby informs you as follows::

#### **1. Data Controllers**

#### **2. Processing purposes**

Your personal data will be collected with electronic and telematic means and processed under the conditions established by Regulation (EU) 2016/679 exclusively for the purposes connected to the Call of the *New Edition of the Claudio Scimone Competition 2024*.

#### **3. Legal basis of Processing**

Processing for the purposes referred to in point 2. is based on your consent and is mandatory since it is necessary for the management of your application. If you do not give your consent, we will not be able to process your application.

#### **4. Categories of recipients**

Your data will be shared by the Competition Jury with:

- a) persons expressly appointed and authorised to carry out exclusively the tasks related to the selection of candidates.
- b) parties, bodies or authorities to which it is mandatory to communicate personal data under the provisions of the law.

#### **5. Retention period**

Your personal data will be retained only for the time necessary to achieve the purposes referred to in point 2., or until the express withdrawal referred to in point 6 below. Data not required to allow the Committee or the Association to fulfil a legal or regulatory requirement will be deleted at the end of the selections.

### 6. Data subject rights
